ORDINANCE NO. CHAPTER 41, AUGUST 2014-1

ORDINANCE SUPPLEMENTING THE CODE OF ORDINANCES OF THE VILLAGE OF FOLSOM TO PROVIDE THAT AN INDEPENDENT CONTRACTOR, WHETHER INDIVIDUAL OR COMPANY, CONTRACTING WITH THE VILLAGE OF FOLSOM AND/OR WORKING FOR THE VILLAGE OF FOLSOM AND/OR PROVIDING SERVICES FOR THE VILLAGE OF FOLSOM MUST PROVIDE PROOF OF BOTH LIABILITY AND WORKMEN'S COMPENSATION INSURANCE AND CERTIFY THAT ANY LICENSES AND/OR CERTIFICATIONS REQUIRED BY THE STATE OF LOUISIANA AND/OR ITS BOARDS OR AGENCIES HAVE BEEN OBTAINED.

BE IT ORDAINED by the Board of Aldermen of the Village of Folsom, that the Village of Folsom Code of Ordinances be supplemented to provide that:

An independent contractor whether individual or company, contracting with the Village of Folsom and/or working for the Village of Folsom and/or providing services for the Village of Folsom must provide proof of both liability and Workmen's Compensation insurance and provide proof of any licensing and/or certifications required by the State of Louisiana.


BE IT FURTHER ORDAINED that if any provision of this Ordinance is held invalid such invalidity shall not effect other provisions, items or applications of this ordinance, which can be given effect without the invalid provisions, items or applications, and to this end the provisions are hereby declared severable.

BE IT FURTHER ORDAINED that this Ordinance shall take effect on and after its promulgation.

Said Ordinance having been introduced on the 13th day of October, 2014, the title having been read and the Ordinance considered, on motion duly made and seconded to adopt the Ordinance, a record vote was taken and the following was had:




