

Item 1 Culvert Data Plan

Mayor announced Item and stated that our Village Engineer Jay Pittman gave him a copy of a culvert verification permit, to ensure when culverts are installed in they are the correct size. Mayor Willie explained that the Culvert Data Plan would be added to or building application.

Mayor requested approval to add the new requirement for culverts to the current building packet. Alderman George Garrett made motion to approve and seconded by Alderman Jill Mathies. (3 Yeas, 0 Nays) Motion carried.
