Item 1 – United States Post Office Mail Delivery Concerns

Mayor Willie announced Item and expressed that he has spoken with the gentleman in charge of all Post Offices in area and he confirmed that he has enough fire (Info) from different representatives to make some changes.

Alderwoman Mathies mentioned about the disclosure form you can get at Town Hall, sign it with your complaint and bring it back signed.

Item 2 - Alley Way/Broadway to Garfield

Mayor opened discussion of the alley way shutdown from Broadway to Garfield (alley behind Jason Cycles, Bernie Quick Shop, Giddy Up, Jr. Food Mart). Mr. Richerand owner of Giddy UP has been hosting a farmer's market on the property behind Giddy Up, within that he has been shutting down the alley way, because of concerns of speeding and traffic during his events. Mayor Willie granted Mr. Richerand the ability to place cones in the alley way for redirection of traffic. Alderwoman Mathies and Alderman Garrett stated that, they had received several calls regarding why permission was given to close the alley way. Chief Killingsworth stated that he had not received any notifications regarding speeding in the area. Chief Killingsworth also stated that he had no prior notice that the road was even closed Alderman Garrett stated that we should not give anyone more privileges than we give anyone else, Alderwoman Mathies stated that she agreed with Alderman Garrett.

After a lengthy discussion Mayor Willie confirmed, when there is a high influx of people at these events, then the Police department is to be contacted and they will decide if the alleyway will need to be redirected of traffic. Mayor Willie stated that he will speak with Mr. Richerand regarding the street closure.

Item 4- Historical Building (Jerry Laiche/Frank Richerand)
