

**ORDINANCE
NO. 1 OF JANUARY 2018**

**AN ORDINANCE OF THE VILLAGE OF FOLSOM ALLOWING THE
MAYOR TO SIGN A QUITCLAIM DEED REGARDING ANY INTEREST THE
VILLAGE MAY HAVE IN THE PROPERTY WHICH THE VILLAGE REVOKED
BETWEEN SABINE STREET AND ST. CLAUDE STREET IN CONSIDERATION
FOR A PAYMENT OF TWO HUNDRED FIFTY DOLLARS**

WHEREAS, the Village of Folsom previously revoked the dedication of Willow Street between Sabine Street and St. Claude Street, the governing authority authorizes the mayor to sign a quitclaim deed relinquishing any interest it may have in said property to the following property owners:

- (1) Debra Lee Rimmel, regarding any interest the Village of Folsom may have in that portion of the revoked Willow Street lying in Lot 10-B, Square 25, Village of Folsom;
- (2) STCL, LLC, regarding any interest the Village of Folsom may have in that portion of the revoked Willow Street lying in Lot 10-A, Square 25, Village of Folsom;
- (3) As to C. J. Brown, regarding any interest the Village of Folsom may have in that portion of the revoked Willow Street lying North of Lot 1, Square 25, Village of Folsom.

The quitclaim deed is in consideration of a payment of Two Hundred Fifty (\$250.00) Dollars by or on behalf of the above named property owners.

BE IT ORDAINED that the mayor is authorized to execute a quitclaim deed of the above described property releasing any interest the Village of Folsom may have to Debra Lee Rimmel, STCL, LLC. and C. J. Brown regarding the property described hereinabove, in consideration for a payment of Two Hundred Fifty (\$250.00) Dollars.


FURTHER, this ordinance shall take effect after its promulgation.

THE FINAL ADOPTION of the foregoing ordinance after being introduced on December 11, 2017, and notice of public hearing being held, the title having been read and the ordinance considered, seconded and adopted, a record vote was taken and recorded as follows:


