

**ORDINANCE
No. 2017-1 - CHAPTER 33**

**AN ORDINANCE ADOPTING AN OPERATING BUDGET
OF REVENUE AND EXPENDITURES FOR THE YEAR
BEGINNING JULY 1, 2017 AND ENDING JUNE 30, 2018**

WHEREAS, for the fiscal year beginning on July 1, 2017, and ending on June 30, 2018, the Mayor of the Village of Folsom has prepared and submitted a proposed budget to the Board of Aldermen, the governing body of the Village of Folsom as provided by law; and,

WHEREAS, said proposed budget was submitted at the proper time at the general meeting held on May 8, 2017, and,

WHEREAS, upon due and proper notice and published in accordance with law, the proposed budget was open for inspection at town hall, a public hearing held on June 12, 2017, and,

WHEREAS, whatever increases may have been made in the expenditures, like increases were added to the revenues or planned to be expended from reserve/fund balances so that the budget remains in balance as required by law.

NOW THEREFORE, BE IT ORDAINED by the Board of Aldermen the governing body of the Village of Folsom that the budget submitted and summarized by fund, hereby is approved and adopted as the budget of the Village of Folsom, for the year stated above.

BE IT FURTHER ORDAINED that the budget as approved and adopted shall be made part of the public records of the Village of Folsom.

Said Ordinance, having been introduced on the 8th day of May 2017, notice of public hearing having been published and public hearing having been held on the 12th day of June 2017, the title having been read and the ordinance considered after motion duly made and seconded, a record vote was taken and said vote was as follows:
