Alderman Shawn Dillon spoke addressing the fact that nobody looked drainage wise before building the houses in the middle of Village Trace and everyone agreed.

Police Report

Item 1 - ARP Funds

Alderman George Garrett announced adjustment request for Lance Willie, customer's faucet blew on the side of his house, none of the water went into the sewer. Customer has requested an adjustment of \$53.80 for the sewer portion of the bill.
