## RESOLUTION

**A Resolution Of The Board Of Aldermen Of The Village Of Folsom Providing For The Billing Of The Annual Administrative Fee Charged Pursuant To The Safe Drinking Water Act To Each Customer For Each Metered Connection**

Whereas the Louisiana Legislature has enacted Act No. 605 of the regular session of 2016, providing for an increase in the administrative fee pursuant to the Safe Drinking Water Act (40:31.33 (A)(1)) to twelve dollars (\$12.00) per metered connection per year and.

Whereas the governing authority of the Village of Folsom is of the opinion that said fee should be billed to each customer in the amount of three dollars (\$3.00) in the months of March, June, September, and December;

Be It Resolved by the Village of Folsom that the twelve dollar (\$12.00) Safe Drinking Water Act fee will be billed for each metered connection by placing a three dollar (\$3.00) charge on the bill for the months of March, June, September, and December. The invoices received from the Department of Health and Hospitals, State of Louisiana, will be remitted no later than the month after they are received. Five percent (5%) of the twelve dollar (\$12.00) fee will be retained by the Village of Folsom for administrative cost.

Said Resolution was moved for adoption and seconded and then submitted to a vote, the vote being as follows:
