### Item 1 Amending the Salary for Chief of Police

Mayor announced item Chapter 1 No 5-2022 an Ordinance of the Village of Folsom amending chapter 1 of the codes of ordinances to provide for a salary for new the Chief of Police of the Village of Folsom. Mayor Willie sated that this is just the introduction to the ordinance, and it will be finalized at the next General Meeting.

#### Item 2 Appointment of Village of Folsom Police Chief

Mayor announced Item and stated that he would like to make his appointment for the new Police Chief of the Village of Folsom, Shilo Bruhl. Alderwoman Jill Mathies made motion to accept the nomination of Shilo Bruhl as Police Chief and seconded by Alderman Shawn Dillon. (3 Yeas, 0 Nays) motion carried.

### Item 3 Recognition of Police former Police Chief Ronnie 'Beau" Killingsworth

Mayor announced Item and stated that the Village would like to recognize Ronnie "Beau' Killingsworth and thank him for 27 years of service to the Village of Folsom.

Mayor Willie introduced former Mayor Marshall Brumfield and former Mayor Bernie Willie.

Mr. Brumfield stated that he has known Chief Killingsworth for several years and that he was and Alderman when Killingsworth was appointed. Mr. Brumfield explained that Chief Killingsworth is a man of wisdom, a man who knows what to do, a man of skill, a man who knows how to do and a man of work.

Mayor Willie announced that the Village of Folsom's new Police Chief Shilo Bruhl will be sworn in. Mayor Willie asked Village Attorney Roy Burns to administer the Oath of Office.
