## 2017-2018 Grant Application

The **World of Wonder (WOW) Fund’s** Legacy Garden Grants for Louisiana schools and nonprofits. Jacqueline “Jinx” Vidrine, Ph.D. established this fund to bring together master gardeners, teachers, parents, and students to plant and harvest vegetables. These grants provide funding for LA public schools and nonprofit organizations to support garden projects which connect students to their food, therefore to their health and to their community. The WOW Fund awards **\$250** for a garden. The funds are designated as \$200 for allowable expenses as outlined below and \$50 stipend for the designated Point Person. To revive a garden, \$100 will be given for soil augmentation and vegetable plants.

### **Who is eligible?**

Any LA public school, PTA or nonprofit organizations who are directly involved in education or community gardens are eligible.

### **How are the grants submitted?**

An application must be filled in and signed by Principal/ Director and the identified Point Person.

### **What are the program requirements?**

All Programs are required to identify of a Point Person to insure garden is in operation. Gardens must be installed and ready prior to each growing season. Photos and all receipts verifying completed installation, progress and successful completion of the season are required supporting documentation. **Due by May 15<sup>th</sup>.**

### **What are allowable expenditures?**

Garden supplies including raised garden boxes, organic soil, vegetable seeds and/or seedlings, hose, sprinkler and/or drip irrigation, mulch, and weed barrier fabric are allowable expenditures.
