

Ordinance No. 94  
October 10, 2007

BE IT ORDAINED BY THE Mayor and the Council of the Town of Madisonville that Chapter 12 Animals, Section 12.3 of the "Code of Ordinances" of the Town of Madisonville be amended as follows:

Section 12.3 shall be repealed in its entirety and replaced to read as follows:


- (a) Every owner or keeper of a dog(s) shall exercise proper care and control of such dog(s) so as prevent them from creating or becoming a public nuisance. All dogs shall be kept on the owner's premises, or if allowed to be on the streets shall be properly restrained by a leash. Excessive or untimely barking, howling or yelping so as to disturb the peace and quiet of a neighborhood or its residents or to disturb the health or repose of the residents; attacking or molesting passerby or other animals; being repeatedly at large; chasing vehicles; scratching on or digging into or urinating or defecating upon lawns, shrubs, buildings or any property, either public or private, other than property of the owner or keeper of the dog(s) all shall be deemed to be the creation of a public nuisance and the owner or keeper of the dog(s) causing such public nuisance shall be subject to penalties set forth in Chapter 17, General Provisions, Section 17.7, General Penalty of the Code of Ordinances. In the case of defecation, the owner or keeper must remove all feces and dispose of them in a sanitary manner or be considered to be further in violation of the provisions of this article.

ORDINANCE NO.: 26  
February 8, 1989

BE IT ORDAINED BY THE Mayor and Council of the Town of Madisonville, Chapter 12, Animals is hereby amended by adding the following Section 12.5:

Section 12.5: The cleaning of fish and the skinning and cleaning of animals and fowl on the sidewalks, streets, and public recreational areas of the Town of Madisonville are hereby declared to be a public nuisance and a menace to the health of the public and are hereby prohibited.

## CHAPTER 12

### Animals

Section 12.1 No one shall permit or cause any goat, hog, sheep, horse, mule, cattle or unvaccinated dog to roam at large within the corporate limits of the Town of Madisonville, La.

Section 12.2 The keeping or maintaining of horses, goats, or cattle within the limits of the Town of Madisonville, State of Louisiana is declared to be a public nuisance being deleterious to the health and welfare of the inhabitants thereof, and in order to prevent and suppress such public nuisance and the spread of contagious diseases it is unlawful for any person to keep or maintain horses, goats, or cattle within the limits of the Town of Madisonville, State of Louisiana.

Section 12.3 All dogs roaming on the streets of the Town of Madisonville, Louisiana are considered a nuisance and a strong menace to the health of the citizens of the said Town. The owners of dogs shall keep their dogs on their premises, or if allowed to be on the streets at all, such dogs shall be properly muzzled, or be led with a rope, chain or other leash.

Section 12.4 All slaughter pens, or the killing or cleaning of cattle for market use, are hereby declared a public nuisance and a menace to the health of the residents of the Town of Madisonville and are hereby prohibited. No person, firm or corporation shall be permitted to slaughter or clean any hogs, sheep or cattle in the corporate limits of the Town of Madisonville, Louisiana.
